## ARTICLE - 9

- [a] Every member shall be entitled to exercise the rights and privileges through himself or through his authorised representative whose name shall be intimated to Chamber from time to time by such member, provided that in case of attending any voting at any General, Special General or Annual General Meeting of the chamber such intimations given to the Honorary Secretary General in writing at least a fortnight before the date of such meeting. Each year a record will be kept by the office of the Chamber showing the names of such authorised representatives and the changes that may be made from time to time therein.
- [b] Every recognised Divisional Chamber shall be entitled to send two representatives to attend any Annual General, Special General or General Meeting of the Chamber.
- [c] Representative of a Company or Corporation means a Director, Managing Director, Manager or Branch Manager, Secretary or other responsible officer of the Company or Corporation who has been duly authorised to represent the Company or Corporation for the time being as member of the Chamber and such a representative will have the right to vote at such meetings.
- [d] Representative of an Association Member means any of its member nominated by the Executive Committee of the Association member to represent it for the time being as member of the Chamber. Such a representative will have the right to vote at such meetings.
- [e] Each Associate Member which is a firm or a Company shall be entitled to nominate one representative to attend all General Meetings of the Chamber. Such a representative will have the right to vote at such meeting.
- [f] Each Donor member shall be entitled to nominate one representative to attend all the General Meetings of the Chamber. Such representative will have the right to vote at such meetings.
